**President’s Report
(Agenda Item 2)**

President Sarchio presented his report, noting the launch of the new D.C. Bar blog “Duly Noted.” He noted with concern that Congress has not confirmed a number of judges nominated to fill vacancies on D.C. courts, including 11 pending nominations on the D.C. Superior Court and one in the D.C. Court of Appeals. In other business, President Sarchio reported that the 2022 Payton Leadership Academy had launched. He reminded the Board that the nomination period for Board vacancies remains open and that nominations for the 2022 Beatrice Rosenberg and Thurgood Marshall Awards must be submitted by February 1. Finally, he reported that Judge Vanessa Ruiz would receive the American Bar Foundation Fellows Outstanding Service Award and that both the ABA Midyear Meeting and National Conference of Bar Presidents would be held remotely in February.
